

**Barilla Instant Win Program  
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.** Barilla Instant Win Program ("Promotion") begins at 9:00:00 AM Eastern Time ("ET") on October 5, 2017 and ends at 11:59:59 PM ET on December 23, 2017 ("Promotion Period"). The Promotion contains a game of chance ("Sweepstakes"). The computer clock of Administrator is the official time-keeping device in the Promotion.
