- 7. Who are participating retailers? Retailers located in the USA, including online retailers; excluding Ebay, Inc.
- 8. How does the BD Rewards Program work? You will receive credits towards BD Rewards for the BD Rewards-covered product(s) you purchase from participating retailers during the dates and according to the instructions outlined herein. You will qualify to receive 2 additional credits each week when you share the BD Rewards Program via Facebook® or Twitter® icons on <a href="https://www.getbdrewards.com">www.getbdrewards.com</a> during Oct. 1, 2016 through Jan. 15, 2017.
