

**Dawn Wildlife Sweepstakes
Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. The Dawn Wildlife Sweepstakes (the "Promotion") begins at 12:00:00 AM Eastern Standard Time ("ET") on July 1, 2018, and ends at 11:59:59 PM ET on October 6, 2018 (the "Promotion Period"). The computer clock of the Sponsor (defined below) is the official time-keeping device in the Promotion.

1. **ELIGIBILITY:** The Promotion is open only to legal residents of the fifty (50) United States and the District of Columbia, who are at least eighteen (18) (except in Alabama and Nebraska nineteen (19) and twenty-one (21) in Mississippi) years of age as of date of entry. Employees, officers and directors of The Procter & Gamble Company ("Sponsor"), Pep Promotions, Snipp Interactive, Realtime Media LLC ("Administrator"), and each of their respective parent companies, affiliates, subsidiaries and advertising, contest, fulfillment and marketing agencies; (collectively, "Promotion Parties") their immediate families (parent, child, sibling & spouse and their respective spouses, regardless of where they reside) and persons living in the same households as such individuals (whether related or not) are not eligible to participate in the Promotion. By participating, you agree to these Official Rules and to the decisions of the Sponsor, which are final and binding in all respects. Void in anywhere not listed above and where prohibited by law, rule or regulation. All federal, state and local laws and regulations apply.

2. **HOW TO ENTER THE PROMOTION:** Participants are able to enter the Promotion via either of the following two (2) methods of entry: (1) submitting a valid receipt of a qualifying purchase, or (2) the free alternate means of entry. No other method of entry will be accepted. Entry methods are detailed below. **Limit of ten (10) total Sweepstakes Entries (as defined below) per person, per email address, regardless of method of entry or number of products purchased throughout the Promotion Period.**

- a) **PURCHASE OF QUALIFYING PRODUCT METHOD:** Purchase any Dawn product from any authorized retailer and submit a photo of the valid receipt ("Receipt Photo") of the qualifying purchase and complete the online registration form available on the Website (as defined below) during the Promotion Period. **Valid on purchases from July 1, 2018, through October 6, 2018. All submissions of Receipt Photos and registration forms must be received by Saturday, October 6, 2018, at 11:59:59PM EST to be eligible.** Before submitting a Receipt Photo, participants must highlight the eligible Dawn product* on the receipt with a star or check. Receipt Photo must clearly show the receipt in its entirety. Participants should keep their original receipt. Sponsor reserves the right to require a participant to provide original receipt for verification purposes upon request. Participants can submit their Receipt Photos and register at <https://dawndishsweeps.com/> (the "Website") during the Promotion Period.

The registration form at the Website must be completed in its entirety by entering your true and correct information in the required fields (required fields include: Full Name, Complete Mailing Address, E-mail Address and Phone Number). A Receipt Photo that contains an eligible Dawn product* received during the Promotion Period will earn an entry into the Sweepstakes (each a "Sweepstakes Entry" or "Entry") for each eligible product. No responsibility is assumed for (i) technical, electronic, telephone, hardware, software or network, computer or data transmission errors, malfunctions or difficulties of any kind or (ii) any incorrect data contained in any Sweepstakes Entry.

- b) **ALTERNATE MEANS OF ENTRY:** To enter without purchase, hand-print your Full Name, Complete Mailing Address, E-mail Address and Phone Number and Birth Date on a plain 3x5 inch paper. Mail your completed entry to Realtime Media, Attn: Dawn Wildlife Sweepstakes Entry, 200 Four Falls Corporate Center, Suite 130, Conshohocken, PA 19428. Each entry must be mailed separately in a hand-addressed, stamped envelope. No photocopied or mechanically reproduced entries will be accepted. No responsibility is

assumed for lost, late, incomplete, illegible, misdirected or postage-due entries. No responsibility is assumed for (i) technical, electronic, telephone, hardware, software or network, computer or data transmission errors, malfunctions or difficulties of any kind or (ii) any incorrect data contained in any sweepstakes entry. **Mail-in entries must be postmarked no later than October 6, 2018 and received by October 11, 2018 to be eligible for the drawing.** All entries become the property of Sponsor and will not be returned or acknowledged.

3. **SWEEPSTAKES DRAWING/ODDS:** On or about October 15, 2018, the Administrator will conduct an electronic randomized drawing from among all eligible Sweepstakes Entries received within the Promotion Period and select Ten (10) potential Grand Prize winners. Odds of winning a Grand Prize depend on the number of eligible Sweepstakes Entries received during the Promotion Period.
4. **WINNER NOTIFICATION:** The potential Grand Prize winners will be notified by email and/or phone within three (3) business days of potential winner selection or as soon as reasonably practicable in Sponsor's sole discretion. Potential winners will have ten (10) days to respond to winning notification before forfeiting his/her prize. The potential Grand Prize winners will be sent an Affidavit of Eligibility/Liability Release via email. All forms must be completed, signed, notarized and returned to Administrator within ten (10) days of date of issuance. A potential winner becomes a "winner" only after verification of eligibility by Administrator in accordance with these Official Rules. If such potential winner cannot be contacted within a reasonable time period, if the potential winner is ineligible, if any notification is returned undeliverable, if the potential winner declines the prize for any reason or if the potential winner otherwise fails to fully comply with these Official Rules, he/she will forfeit that prize and an alternate potential winner will be selected from among all remaining eligible Sweepstakes Entries.
5. **PRIZES/PRIZE RESTRICTIONS:** Ten (10) Grand Prizes will be awarded during the Promotion as detailed below:

GRAND PRIZES (10): Ten (10) Grand Prizes will be awarded. Each Grand Prize will consist of:

- One (1) trip for four (4) (winner and three (3) guests) to San Francisco, California. Prize package includes:
 - Round-trip coach air transportation for winner and three (3) guests from a major airport, as determined by Sponsor, near the winner's home within the continental U.S. to San Francisco, California
 - One (1) standard room for four (4) for five (5) days/four (4) nights
 - Roundtrip ground transportation to and from airport and hotel
 - \$500 spending money awarded in the form of an AMEX Gift Card
 - Four (4) tickets to one (1) of the activities listed below and roundtrip ground transportation to and from the hotel and activity:
 - Golden Gate Whale-Watching Tour
 - Marin Headlands Day Excursion
 - Pier 39 Attractions Pass

The Approximate Retail Value ("ARV") of each Grand Prize is \$7,000.

The ARV of all Promotion Prizes is \$70,000.

GRAND PRIZE RESTRICTIONS: Actual prize value depends on the location of the winner's residence and dates of travel. **Travel must be taken before October 6, 2019 and must be reserved fourteen (14) days in advance or prize will be forfeited and Sponsor will have no further obligation to such winner.** Any difference between stated value and actual value will not be awarded. Winner is responsible for any transportation not specifically noted in these rules. Winner and guests must travel together on the same itinerary and are responsible for obtaining all necessary travel documents prior to travel. Certain restrictions, as determined by Sponsor, may apply. Sponsor will attempt to accommodate winner's preferred itinerary, but all specifics thereof

will be at Sponsor's discretion. Sweepstakes Entries generated by a script, macro or other automated means will be disqualified. Sweepstakes Entries that are incomplete, garbled, or corrupted are void and will not be accepted.

Failure to comply with these Official Rules may result in disqualification. - 8. CONSENT:** Receipts obtained through unauthorized means or illegitimate channels will be void. Receipts cannot be sold, traded, auctioned, or bartered; all of which will be void. Duplicate receipts and receipts from resellers, dealers/distributors, their employees or warehouse facilities, groups, clubs or organizations will be void. All requests become the property of Released Parties (defined below) and will not be returned. Fraudulent submission could result in federal prosecution under mail fraud rules and regulations. By participating in the Promotion, you agree (i) to release, discharge, indemnify and hold harmless the Promotion Parties and each of their respective parent, subsidiaries, affiliates, retailers, and advertising and promotion agencies, and all of their respective officers, directors, shareholders, employees and agents (collectively, "Released Parties") from any liability or damages which may arise out of participation in the Promotion or out of the acceptance, use, misuse or possession of and prize (or any portion thereof). All applicable federal, state and local laws and regulations apply.
