

## Far East Brokers GrillPerks™ Rewards Program Terms and Conditions

### PLEASE READ CAREFULLY.

Membership in the GrillPerks™ Rewards Program (the "Program") is subject to the Program's Terms and Conditions set forth below ("Terms and Conditions", or "Terms"). These Terms and Conditions supersede all previous rewards or loyalty program terms and conditions, rules, regulations, policies and procedures that may have been in effect. The current phase of the Program begins on February 1, 2019, at 12:00:00 a.m. ET and is scheduled to end on January 31, 2020, at 11:59:59 p.m. ET ("Program Period"). Create Your Account by following the instructions at [www.grillperks.com](http://www.grillperks.com), including choosing the Reward that you would want your eligible Points to be redeemed for (as set out in Section E(1) below). Once you have an Account, you can log in and follow the instructions to complete Proof of Purchase Transactions. Each Proof of Purchase Transaction will add Program points ("Points") to your Account. The number of Points to be earned varies by Participating Product. You can then redeem these Points for Rewards as provided for in Section E of these Terms and Conditions. 3. Any retailer in the United States, other than the ineligible retailers set out in Appendix C to these Terms and Conditions, is a "Participating Retailer" for the purposes of this Program.

FOR CLARITY, ANY PURCHASE OF PARTICIPATING PRODUCTS FROM ANY OF THE INELIGIBLE RETAILERS LISTED IN APPENDIX C WILL NOT BE ELIGIBLE FOR POINTS, REWARDS OR PARTICIPATION IN THE PROGRAM.

#### **C. Participation in the Program.**

Text receipt to 811811: Participants text the following to 811811 evidencing the single purchase transaction: the keyword GRILLPERKS and an image of the entire purchase receipt that clearly identifies the Participating Retailer and date of sale and has a star (\*) or a checkmark (☑) next to the Participating Mr. Bar-B-Q® Product(s) or Participating Mr. Bar-B-Q® Product(s) and the Participating Partner Product (defined below as “Mr. Bar—B—Q®” or “Partner Brand” in “Type Of Products” column in Exhibit B). Text must be sent from the mobile phone number tied to your Account.

2. Only receipts from purchase made at Participating Retailers from inside the U.S. are eligible for the Program. Only those images that include in a legible manner the store name, date of purchase, serial number, item names, and prices will be considered as an eligible receipt for the purpose of obtaining Points. If any such contingency shall last for more than sixty (60) days, Sponsor shall have the right to terminate the Program immediately by giving notice and shall have no further obligation to any member.

10. Sponsor's failure to exercise or enforce any right or provision of these Terms and Conditions shall not constitute a waiver of such right or provision unless acknowledged and agreed to by Sponsor in writing.
