Message and data rates may apply. By participating via text-messaging, you will receive up to 8 promotional text messages in response to your text from an automated system. Consent is not required to buy goods and services. You may not be able to participate by text message through all wireless carriers.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

BY PARTICIPATING IN THE PROGRAM, PARTICIPANTS AGREE TO THESE TERMS AND CONDITIONS (“TERMS”), WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE PARTICIPATING. 3. How to Participate

Make a Qualifying Purchase and submit a photo of the valid retail receipt (“Receipt Photo”) of the Qualifying Purchases, and register for the Program at www.Get5withZen.com (the “Website”). All submissions of Receipt Photos must be received by Monday, October 30, 2017 at 11:59:59PM EST to be eligible. Before submitting a Receipt Photo, participants must highlight

the *Qualifying Zebra Pen products on the receipt with a star or check. Receipt Photo of receipt must clearly show the receipt in its entirety. Participants should keep their receipt. Zebra Pen reserves the right to require a participant to provide original receipt for verification purposes upon request. Participants can submit their receipt via any of the three (3) methods below:

Participant will first receive a text message with opt-out instructions and disclosure for receipt of up to eight (8) automated text messages to the number provided, along with instructions for Receipt Photo submission. Limit of 160 characters per text. You will be sent a link to the registration form to register for the Program via text.

- c) Upload your Receipt Photo at www.Get5withZen.com and register for the Program.

Complete the registration form by entering your true and correct information in the required fields (required fields include: Full Name, Complete Mailing Address, E-mail Address, and Phone Number).

4. Redemption

Participants must submit a valid retail receipt via one (1) of the above methods to receive one (1) Reward, while supplies last. Rewards are subject to provider’s full terms and conditions. Upon receipt and verification of a valid purchase of \$9.99 worth of *Qualifying Zebra Pen products after savings during one (1) transaction, digital Rewards will be sent to the email address supplied during registration and physical Rewards will be sent to the mailing address supplied during registration. All requests become the property of Released Parties and will not be returned. Program is void where taxed, prohibited, or restricted by law. 8. Suspension / Modification / Termination

In the event Sponsor is prevented from continuing with the Program by any event beyond its control, including, but not limited to, fire, flood, epidemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, communications or equipment failure, utility or service interruptions, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared), interference with the Program by any party, or any federal, state, local or provincial government law, order, or regulation, order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each a "Force Majeure" event or occurrence), Sponsor shall have the right to modify, suspend or terminate the Program or any Rewards. Sponsor additionally reserves the right, in its sole and absolute discretion: (a) to modify, suspend or terminate the Program should causes beyond Sponsor's control corrupt or interfere with the administration, integrity, operation, security or proper play of the Program; or (b) to disqualify any entrant found to be, or suspected of: (i) tampering with the entry process or the operation of the Program; (ii) acting in violation of these Official Rules; or (iii) acting in an un-sportsmanlike manner.

9. Governing Law / Limitation of Liability

All issues and questions concerning the construction, validity, interpretation and enforceability of these Terms or the rights and obligations of participants, Sponsor or the Released Parties in connection with the Program will be governed by and construed in accordance with the internal laws of the State of New Jersey, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.

BY PARTICIPATING IN THE PROGRAM, ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (A) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE PROGRAM, OR ANY REWARD AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (B) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED TEN DOLLARS (\$10.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (C) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED TEN DOLLARS (\$10.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (D) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU. PARTICIPANT'S SOLE REMEDY FOR ANY FAILURE TO ENABLE A REWARD FROM A VALID REWARD SHALL BE A REPLACEMENT REWARD FOR THE SAME REWARD VALUE.

10. Dispute Resolution

The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts

in Middlesex County, New Jersey and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Program shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in Middlesex County, New Jersey. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in Middlesex County, New Jersey. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.

11. Miscellaneous

The invalidity or unenforceability of any provision of these Terms will not affect the validity or enforceability of any other provision. In the event that any provision of the Terms is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Terms will not constitute a waiver of that provision. Participants agree to waive any rights to claim ambiguity of these Official Rules. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Program-related materials, privacy policy or terms of use on any website, social media platform or application and/or the terms and conditions of the Terms, the Terms shall prevail, govern and control and the discrepancy will be resolved in Sponsor's sole and absolute discretion.
