

Lutron-Contractor Receipt Reward Program Terms and Conditions (“Terms and Conditions”)

1. Eligibility

The Lutron-Contractor Receipt Reward Program (“Program”) begins Sunday, February 11, 2018 at 9:00:01AM Eastern Time (“ET”) and ends on Monday, April 29, 2018 at 11:59:59PM ET (“Reward Period”). Participation in the Program is only open to Electrical Contractors who are legal residents of the 50 United States (and the District of Columbia) or the 10 provinces of Canada, and are 18 years of age or older at the time of entry (“Participant”). Participants must be licensed electrical contractors or employed by a licensed electrical contractor as defined by the licensing boards in their respective state or province, unless their state or province does not have a licensing board, in which event Participants must be able to provide, upon Sponsor’s request, a form or certification that their state or province uses in place of a license. By entering Program, each Participant acknowledges and agrees that his/her participation in the Program may be subject to, or prohibited or restricted by, his/her employer’s policies and regulations and that the Participant is solely responsible for review of, and compliance with, any such policies or regulations of his/her employer. Violations of employer policies, as determined by Sponsor in its sole discretion, may void entry and Reward or result in Sponsor’s re-assignment of Reward to employer. Rewards shall be paid in the name of the purchaser for qualifying purchases. See paragraph 2 below for restrictions on calculation of Rewards. If purchaser is not a natural person (e.g., XYZ Contracting Inc.) the purchaser may designate one or more employees as authorized Participants.

2. Reward Program

Participants may participate in the Program by purchasing at least \$100 worth of any eligible Lutron Electronics products* (**listed within the Appendix below**) from a retailer on the list of participating retailers that is featured at <http://www.lutron.com/crushit> during the Reward Period (“Qualifying Purchase”). All Participants who make a Qualifying Purchase and submit a photo of the receipt as provided in these Terms & Conditions, will receive one (1) \$10 Prepaid Virtual Visa® (“Prepaid Virtual Visa® CAD”, for Canadian residents) or one (1) physical \$10 Visa® gift card (“Reward”). The Approximate Retail Value of each Reward is \$10.00 and is subject to the standards terms and conditions governing Visa® Prepaid Virtual Visa® CAD and Visa® gift cards. Participants will receive an additional Reward for each \$500 worth of any eligible Lutron Electronics products* purchased during the Reward Period after the first Qualifying Purchase up to a maximum of fifty (50) Rewards, per participant including the initial Reward. Rewards may not total more than \$500 (FIVE HUNDRED DOLLARS) per account per location, regardless of the number of employees participating in the Program (e.g., if a contractor has two locations, the contractor and its employees are eligible for a total of \$1000 (ONE THOUSAND DOLLARS) in Rewards, even if 10 employees are participating in the Program) NOTE: Rewards shall be paid in the name of the purchaser for qualifying purchases. Make a Qualifying Purchase and take a photo of the valid receipt (“Receipt Photo”) showing the Qualifying Purchase(s). Receipt Photos must clearly show the receipt in its entirety. Participants should keep their receipt(s). Sponsor reserves the right to require a participant to provide original receipt(s) for verification purposes upon request. Failure to provide original receipts on Sponsor’s request or to highlight receipts properly may void entry or bar Reward. Participants can submit their Receipt Photos via any of the three (3) methods below:

- a) Text the keyword “**CRUSH IT**” in the United States, OR “**CRUSH18**” in Canada to 811811 to receive a text message with Receipt Photo instructions. Msg & data rates may apply and are the responsibility of Participant. Participant will first receive a text message with opt-out instructions and disclosure for receipt of up to eight (8) automated text messages to the number provided, along with instructions for Receipt Photo submission. One of the automated text messages will include a link to the registration form to register for the Program via text.
- b) Email your Receipt Photo(s) to redem@Lutroncrushit.com.
- c) Register for the Program and upload your Receipt Photo(s) at www.lutroncrushit.com (the “Website”).

All submissions of Receipt Photos must be received by Tuesday, May 29, 2018 at 11:59:59PM ET to be eligible to receive a Reward. Regardless of method of submission, the registration form must be completed in its entirety by entering your true and correct information in the required fields (required fields include: Full Name, Complete Mailing Address, E-mail Address and Phone Number and Reward Fulfillment Type). **Limit of fifty (50) Rewards (\$500) per Participant, per email address.** Each contractor retail account counts as a single Participant for purposes of calculating maximum Rewards, regardless of the number of employees participating in the Program.

Participants must submit valid Receipt Photos via the method above to receive a Reward. Receipts received during Reward Period will be reviewed and validated within forty-eight (48) hours. Upon receipt and verification of the Qualifying Purchase, participants will be sent their Reward. Digital Rewards will be fulfilled via email on a case-by-case basis following verification, with instructions for redemption. Physical Rewards will be fulfilled cumulatively once each month during the Reward Period including Rewards that have been verified at the time of redemption. Available Rewards that have not been verified at the time of redemption will be carried over to the following month and paid after verification with the next monthly payment. Your consent to the above is required to participate in the Program but is not required to make a purchase. You may text HELP to 811811 at any time for help, or text STOP to opt-out. **Carrier specific charges for text messages may apply, including error messages, depending on your individual cellular**
