Official Terms and Conditions

PURCHASE IS NECESSARY. INTERNET ACCESS AND A VALID E-MAIL ACCOUNT ARE REQUIRED.

Standard data and messaging rates apply to participate in the Program (defined below in Section 2) via a mobile device. Please contact your service provider for pricing and service plan information and rates before mobile device participation.

1. AGREEMENT TO BE LEGALLY BOUND BY THE TERMS AND CONDITIONS:

By participating in this Program, you are signifying your agreement that you have read and agree to be legally bound by these Official Terms and Conditions (the “**Terms and Conditions**”).

2. ELIGIBILITY

The Unilever® Canada Xbox Game Pass Program (the “**Program**”) begins on October 03, 2018 at 12:00:00 a.m. Eastern Time and ends on November 03, 2018 at 11:59:59 p.m. Eastern Time or once all Rewards (defined in Section 3 below) have been claimed, whichever occurs first (the “**Program Period**”). Participation in the Program is only open to legal residents of Canada who have reached the legal age of majority in their province or territory of residence at the time of participation (each such resident, a “**Participant**”, or “**you**”). Unilever Canada Inc. (the “**Sponsor**”), Microsoft Corporation, Microsoft Canada, or Snipp Interactive Inc., their respective affiliated and related companies (including, without limitation, their respective parent, sister and subsidiary companies), advertising and promotional agencies, or other party in any way involved in the development or administration of this Program (collectively, the “**Program Parties**”), suppliers of materials or services related to the Program, or a member of the immediate family or household of any such person, are excluded from participation in the Program. The Sponsor, other Program Parties, and each of their respective officers, directors, agents, representatives, successors, and assigns (collectively, the “**Released Parties**”) are not responsible for, and accept no liability whatsoever in relation to, any late, lost, misdirected, delayed or incomplete Program-related information (all of which is void).

3. PROGRAM OVERVIEW

The Sponsor is offering eligible Participants the opportunity to receive a 7 day trial game pass for Xbox One (the “**Reward**”), while supplies last, when they purchase 1 (one) or more Participating Products (defined below in Section 4) from a Participating Retailer (defined below in Section 4) within one (1) transaction (one (1) single sales receipt) during the Purchase Period (defined below in Section 4) in accordance with these Terms and Conditions. **Limit of 3 Rewards per household, email address, and per Participant.**

4. ELIGIBLE PURCHASES

To be eligible to receive a Reward (while supplies last), you must purchase one or more of the participating products listed in Schedule A (the “**Participating Products**”) in one (1) transaction (on one (1) single sales receipt) at a participating retailer in Canada (a list of the participating retailers is included in Schedule B) (the “**Participating Retailers**”) between October 03, 2018 at 12:00:00 a.m. Eastern Time and November 03, 2018 at 11:59:59 p.m. Eastern Time (the “**Purchase Period**”) in full compliance with these Terms and Conditions (collectively, an “**Eligible Purchase**”). Next, Reward Requests (as defined in Section **Error! Reference source not found.** below) must be received before the end of the Program Period (the “**Reward Request Deadline**”) in accordance with these Terms and Conditions.

5. REWARD REQUESTS

Once you’ve completed an Eligible Purchase, obtain the original sales receipt associated with the Eligible Purchase (the “**Eligible Purchase Receipt**”) and ensure that it identifies the Participating Retailer, date of purchase (ensure it is within the Purchase Period) and add a star (*) or checkmark (√) next to the 1 (one) or more Participating Products purchased. Next, take a photograph (png, jpeg, pdf, and tiff file types with a maximum file size of 10MB) of the Eligible Purchase Receipt in its entirety (such photograph, an “**Image**”) (note: you are encouraged to blank out any personal information that appears on the sales receipt) and submit a Reward request (a “**Reward Request**”) before the Reward

6. PROCESSING OF REWARD REQUESTS:

Processing of an Reward Request will take 48 hours from the time the Reward Request is received by or on behalf of the Sponsor. Once a Participant's Reward Request is processed, such Participant will be notified via email, whether such Reward Request has been successfully validated (see Section 7 and Section 8 for details) or a reason why such Reward Request could not be processed at such time, as determined by the Sponsor in its sole and absolute discretion.
