PURCHASE IS NECESSARY. INTERNET ACCESS AND A VALID E-MAIL ACCOUNT ARE REQUIRED.

1. AGREEMENT TO BE LEGALLY BOUND BY THE TERMS AND CONDITIONS:

By participating in this Program (defined below in Section 2), you are signifying your agreement that you have read and agree to be legally bound by the terms and conditions of these Official Terms and Conditions (the "Terms and Conditions").

2. ELIGIBILITY

Nestlé Waters' Sparkling 7 Day Challenge (the "**Program**") begins on February 10, 2020 at 12:00:01 a.m. Eastern Time and ends on April 19, 2020 at 11:59:59 p.m. Eastern Time (the "**Program Period**"). 3. THE PROGRAM

Participants may participate in the Program by purchasing one (1) or more Participating Products from a Participating Retailer within one (1) transaction (one (1) single sales receipt) during the Purchase Period as defined in Section 4 above; ensuring that the applicable sales receipt identifies the Participating Retailer and date of purchase; adding a star (*) or checkmark ($\sqrt{}$) next to the one (1) or more Participating Products identified in the sales receipt; providing the original version of the sales receipt in its entirety (note: Participants are encouraged to blank out any personal information that appears on the sales receipt) and submitting a request to participate in the Program via the Rebate Form found on the Program Site, along with the receipt, by using only the submission methods detailed below (such submission, a "Request"):
