

## **Ripple Foods Money Back Taste Guarantee Terms and Conditions**

### **1. Eligibility**

Ripple Foods Money Back Taste Guarantee ("Program") begins on Monday, August 14, 2017 at 12:00:00AM Eastern Standard Time ("EST") and ends on Sunday, September 10, 2017 at 11:59:59PM EST ("Refund Period"). Participation in the Program is only open to legal residents of the fifty (50) United States and the District of Columbia, who are 18 years of age or older. **Limit of one (1) Refund (as detailed below) per person, per household.**

### **2. Refund Program**

Participants may participate in the Program after making a purchase of one (1) eligible 48-oz Ripple Pea-Based Non-Dairy Milk product (as listed below), in store during the Refund Period ("Qualifying Purchase"). All submissions of Receipt Photos must be received by Saturday, September 30, 2017 at 11:59:59PM EST to be eligible. Before submitting a Receipt Photo, participants must highlight the Eligible 48-oz Ripple Foods Product on the receipt with a star or check. Receipt Photos must clearly show the receipt in its entirety. Participants should keep their receipt(s). Ripple Foods, PBC reserves the right to require a participant to provide original receipt for verification purposes upon request. Participants can submit their receipt on the Website. Participants will also need to complete the registration form by entering their true and correct information in the required fields including why they were unsatisfied with their purchase (minimum of fifteen (15) characters).
