

**Sparkling ICE Trailer Sweepstakes  
Official Rules**

**IMPORTANT:** Please read these Official Rules before entering this Sweepstakes. By participating in this Sweepstakes, you agree to be bound by these Official Rules and represent that you satisfy all the eligibility requirements below.
