

**Sparkling Ice® Trailer Sweepstakes
Official Rules**

IMPORTANT: Please read these Official Rules before entering this Sweepstakes. By participating in this Sweepstakes, you agree to be bound by these Official Rules and represent that you satisfy all the eligibility requirements below.

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. Sparkling Ice® Trailer Sweepstakes ("Promotion") begins at 12:00:00 AM Eastern Time ("ET") on May 3, 2018 and ends at 11:59:59 PM ET on July 4, 2018 ("Promotion Period"). The Promotion contains a game of chance ("Sweepstakes"). The computer clock of Sponsor is the official time-keeping device in the Promotion.

1. ELIGIBILITY: The Promotion is open only to legal residents of the 50 United States and the District of Columbia, who are at least 18 years of age (or the minimum age of majority in their state of residence, if higher than 18 years) at the time of entry. Employees, officers and directors of Talking Rain Beverage Company, Inc (the "Sponsor"), Catapult Marketing, Snipp Interactive, and Realtime Media LLC, their respective parent companies, affiliates, subsidiaries, advertising, and fulfillment and marketing agencies, (collectively, "Promotion Parties") their immediate families (parent, child, sibling & spouse and their respective spouses, regardless of where they reside) and persons living in the same households as such individuals (whether related or not) are not eligible to participate in the Promotion. (a) Purchase a Sparkling Ice product from a Weis Market location during the Promotion Period. At checkout, have your loyalty card scanned and you will automatically receive one (1) Sweepstakes Entry.

(b) To enter during the Promotion Period without purchase, visit sparklingtailgate.com/weis.aspx. Participants will be directed to the registration form where they must completely enter their true and correct information in the required fields (required fields include: Full Name, Complete Mailing Address, Email Address, and Phone Number). Upon completing registration, you will receive one (1) Sweepstakes Entry.

Limit of one (1) Sweepstakes Entry per person, per email address, per phone number, during the Promotion Period. Entrants may not share an email address or cellular accounts.

3. SWEEPSTAKES DRAWINGS/ODDS: On or about July 11, 2018, the Administrator will conduct an individual electronic randomized drawing from all eligible Entries received during the Promotion Period to select one (1) potential Grand Prize Winner. Odds of winning the Grand Prize depend on the eligible entries received during the Promotion Period.

4. WINNER NOTIFICATION: The potential Grand Prize winner will be notified by email and/or phone within three (3) business days of winner selection or as soon as reasonably practicable. Potential winner will have five (5) days to respond to winning notification before forfeiting their prize. Any winner of a prize package valued at \$600 or more will be sent an Affidavit of Eligibility/Liability Release via email.

All forms must be completed, signed, notarized and returned to Administrator within five (5) days of date of issuance. Potential winner becomes the "Winner" only after verification of eligibility by Sponsor.
