

**Tito's Holiday Give Back GWP Program  
Official Rules**

**NO PURCHASE, PAYMENT OR TEXT NECESSARY TO ENTER OR WIN. A PURCHASE, PAYMENT OR TEXT OF ANY KIND DOES NOT INCREASE YOUR CHANCES OF WINNING. STANDARD TEXT MESSAGE RATES WILL APPLY TO ALL TEXTS SENT AND RECEIVED. VOID WHERE PROHIBITED. Tito's Holiday Give Back GWP Program ("Promotion") begins at 12:00:01 AM Eastern Time ("ET") on October 15, 2017 and ends at 11:59:59 AM ET on January 3, 2018 ("Promotion Period"). The Promotion contains a game of chance ("Sweepstakes"). *The computer clock of Sponsor is the official time-keeping device in the Promotion.***

- 1. ELIGIBILITY:** The Promotion is open only to legal residents of the 50 United States and the District of Columbia (includes Alaska and Hawaii), who are at least 21 years of age or older at the time of entry. Employees, officers and directors of Tito's Handmade Vodka, Fifth Generation, Inc. and its subsidiaries (the "Sponsor"), Snipp Interactive, and Realtime Media LLC, their respective parent companies, affiliates, subsidiaries, advertising, and fulfillment and marketing agencies, (collectively, "Promotion Parties") their immediate families (parent, child, sibling & spouse and their respective spouses, regardless of where they reside) and persons living in the same households as such individuals (whether related or not) are not eligible to participate in the Promotion. Once a keyword is received, you will then receive a response text with a compliance message & a link to the Website to upload your Receipt Photo and register at <http://www.titosgiveback.com/> (the "Website"). Participants must enter their Date of Birth & then completely enter their true and correct information in the required fields (required fields include: Full Name, Complete Mailing Address, Email Address, Phone Number, Ugly Sweater Selection and Size). Each eligible completed registration form received will earn one (1) Entry into the Sweepstakes ("Sweepstakes Entry").

Upon submitting the registration form, you will receive one (1) Sweepstakes Entry.

- b) **ALTERNATE MEANS OF ENTRY (AMOE):** To enter without purchase, hand-print your full name, full mailing address, email address, phone number, and birth date on a plain 3x5 inch paper, Ugly Sweater Selection and Size). Mail your completed entry to Realtime Media, Attn: Tito's Holiday Giveback Sweepstakes Entry, 200 Four Falls Corporate Center, Suite 130, Conshohocken, PA 19428. Each entry must be mailed separately in a hand-addressed, stamped envelope. No photocopied or mechanically reproduced entries will be accepted. No responsibility is assumed for lost, late, incomplete, illegible, misdirected or postage-due entries. A total of Five Hundred (500) Promotion Prize Winners will be selected during the Promotion Period. Odds of winning depend on the number of eligible Entries received during the Promotion Period.
4. **PRIZE NOTIFICATION/AWARDING:** Prizes will be fulfilled directly to the mailing address supplied during registration within three (3) to four (4) weeks after the drawing date.
