31 Days of DiGiorno Sweepstakes Official Rules

Photographs must be submitted in .jpeg, .jpg or .gif format, at least 500 pixels wide and no larger than 10 MB. Each Photo Entry must be submitted separately. By submitting a Photo Entry, you hereby grant permission for your Photo Entry to be posted on Sponsor's online social networks and otherwise used by Sponsor as set forth herein.
