

**Dreyer's Grand Ice Cream Have Happy on Hand Gift With Purchase Program  
(the "Program")**

**Official Terms and Conditions**

**PURCHASE IS NECESSARY. INTERNET ACCESS AND A VALID E-MAIL ACCOUNT ARE REQUIRED. A mobile device may also be used to participate.** Standard data and messaging rates may apply to participate in the Program via a mobile device. Please contact your service provider for pricing and service plan information and rates before mobile device participation.

**1. AGREEMENT TO BE LEGALLY BOUND BY THE TERMS AND CONDITIONS:**

By participating in the Program (defined below in Section 2), you are signifying your agreement that you have read and agree to be legally bound by the terms and conditions of these Official Terms and Conditions (the "**Terms and Conditions**").

**2. ELIGIBILITY**

Purchases of Participating Products made through any other retailers or online websites will not be accepted and will not be eligible for this Program.

**4. PROGRAM PERIOD AND KEY DATES**

The Program begins on May 15, 2020 at 12:00:00 a.m. Eastern Time and ends on September 15, 2020 at 11:59:59 p.m. Eastern Time (the "**Program Period**"). The following are other **Key Dates** for the Program:

- (i) **Purchase Period: From May 15, 2020 at 12:00:00 a.m. Eastern Time to August 31, 2020 at 11:59:59 p.m. Eastern Time.** All qualifying purchases must be made within the Purchase Period in order to be eligible for this Program.
- (ii) **Receipt Submission Period: From May 15, 2020 at 12:00:00 a.m. Eastern Time to September 15, 2020 at 11:59:59 p.m. Eastern Time.** All receipts must be submitted within the Submission Period in order to be eligible for this Program.

To be eligible to receive a Reward, purchases of Participating Products (as defined in Section 3) must be made within one (1) or multiple transactions (one (1) single or multiple sales receipts) at a Participating Retailer (as defined in Section 3) during the Purchase Period, while supplies last and in full compliance with these Terms and Conditions.
