

**El Mejor Nido Celebrations Sweepstakes
Official Rules**

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Sweepstakes Period: The El Mejor Nido Celebrations Sweepstakes (“Sweepstakes”) begins at 12:00:01 A.M. Eastern Time (“ET”) on September 15, 2022 and ends at 11:59:59 P.M. ET on December 31, 2022 (“Sweepstakes Period”). The Sweepstakes consists of four (4) separate entry periods: “Entry Period 1”; “Entry Period 2”; “Entry Period 3”; and “Entry Period 4” (as described in the chart below).

Eligibility: The Sweepstakes is open to legal residents of the fifty (50) United States or the District of Columbia, who are at least eighteen (18) years of age, or the age of majority in their state of residence (which is nineteen (19) in Alabama and Nebraska, twenty-one (21) in Mississippi, and eighteen (18) in all other states) at the time of entry. Void where prohibited or restricted by law. Employees of Sponsor, Administrator, Hy Cite Enterprises, LLC (“Prize Provider”) or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production, execution, or distribution of the Sweepstakes (collectively with Sponsor, Administrator and Prize Provider, the “Sweepstakes Entities”), and any of their respective parent and affiliate companies or subsidiaries, as well as the immediate family (spouse, parents, and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee are not eligible to enter or win.

The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s and Administrator’s decisions, which are final and binding in all matters related to the Sweepstakes.

How To Enter: During the Sweepstakes Period, visit www.keeplifedelicious.com/elmejornido/royal-prestige-cookware-sweepstakes/ (“Website”) and follow the instructions to provide your first name, last name, home address including Zip Code (no P.O. Boxes), phone number, birthdate (month and day), phone number and email address, and then click “Submit” (“Base Entry”). Entrants will agree to receive emails from Nestle as part of the Base Entry process and can unsubscribe from receiving emails at any time. **Limit one (1) Base Entry per person/email address for the entire Sweepstakes Period.**

How To Receive one (1) additional entry:

- **Via social media:** During the Sweepstakes Period, after submitting your Base Entry that meets the requirements as set forth above, click the Facebook logo or Twitter logo (the “Social Logos”, and each a “Social Logo”) on the Website to receive one (1) additional “bonus” entry (“Social Bonus Entry”). Note: you only have to click on either of the Social Logos to receive a Social Bonus Entry and you are not required to complete any sort of share action on either of the applicable social media platforms in order to receive the Social Bonus Entry. **The opportunity to obtain a Social Bonus Entry is only available during the same online session in which the Base Entry was received.**
- **Via email/refer-a-friend:** During the Sweepstakes Period, after submitting your Base Entry that meets the requirements as set forth above, use the Refer-A-Friend email share option to share the Sweepstakes via your personal email account. Entrants who refer an eligible friend or family member via email who then enters the Sweepstakes via the original entrant’s referral communication, will receive one (1) additional “email bonus” entry (“Email Bonus Entry”). **The opportunity to obtain an Email Bonus Entry is only available during the same online session in which the Base Entry was received.**

Regardless of Bonus Entry method, limit one (1) Bonus Entry per person/email address for the entire Sweepstakes Period.

As used herein, “Entry” and “Entries” refers collectively to Base Entry/Entries and Bonus Entry/Entries. To be included in a random drawing (as described below), Entries must be received by the end of the applicable Entry Period. Entrants who do not follow all of the instructions, do not provide the required information on the entry form, or do not abide by these Official Rules or other instructions of Sponsor and/or Administrator may be disqualified. Sponsor is not responsible for misdirected email or entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error, which may occur in the processing of the Entries.

Drawings/Winner Notifications: There will be four (4) random drawings held in this Sweepstakes. The random drawings will take place on or about the following dates: October 3, 2022 (“Drawing #1”); November 1, 2022 (“Drawing #2”); December 1, 2022 (“Drawing #3”); and January 3, 2023 (“Drawing #4”). For each drawing, Administrator will randomly select ten (10) prize winners from among all eligible Entries received during the respective Entry Period. The odds of winning a prize depends on the total number of eligible Entries received during the respective Entry Period. **All non-winning Entries from any Entry Period Drawing will be included in the subsequent random drawings.** Each winner is considered a “potential” winner pending verification of his/her eligibility and compliance with these Official Rules. Administrator will make two (2) attempts within a twenty-four (24) hour period to notify each potential winner at the email address or phone number submitted at the time of his/her Entry. Potential winners must respond within forty-eight (48) hours of notification. Failure of a potential winner to respond within forty-eight (48) hours of notification may result in disqualification and an alternate potential winner may be selected. By entering the Sweepstakes, each entrant accepts and agrees to these Official Rules and the decisions of Sponsor and Administrator, which shall be final. Winners may be required to sign a winner’s agreement and Release and return it by the date specified in Administrator’s notification, or prize will be forfeited in its entirety and

another winner may be selected. If a potential winner is found not to be eligible or not in compliance with these Official Rules, or if prize notification or prize is returned as undeliverable, such potential winner may be disqualified and an alternate potential winner may be selected. Sponsor and Administrator are not responsible for any change of email address or phone number of any entrant. By submitting an Entry, each entrant agrees to allow use of his or her name, likeness and/or biographical information for promotional purposes (including posting on the Website), except where prohibited.

Prizes: Forty (40) total prizes will be awarded in the Sweepstakes. Ten (10) Entry Period 1 prizes; ten (10) Entry Period 2 prizes; ten (10) Entry Period 3 prizes; and ten (10) Entry Period 4 prizes.

Each Entry Period 1 prize will consist of the following: one (1) Royal Prestige® 1.5-quart stainless steel saucepan with lid from the Novel™ line. Approximate Retail Value (“ARV”) of each Entry Period 1 prize is \$599. **Total ARV for all Entry Period 1 prizes is \$5,990.**

Each Entry Period 2 prize will consist of the following: one (1) Royal Prestige® 8” non-stick skillet with a glass lid, crafted with plasma technology and premium materials, from the Deluxe Easy Release line. ARV of each Entry Period 2 prize is \$599. **Total ARV for all Entry Period 2 prizes is \$5,990.**

Each Entry Period 3 prize will consist of the following: one (1) Royal Prestige® 2.6-quart, stainless steel stovetop Chocolatera with pot, lid and volcano cone. ARV of each Entry Period 3 prize is \$559. **Total ARV for all Entry Period 3 prizes is \$5,590.**

Each Entry Period 4 prize will consist of the following: one (1) Royal Prestige® Royal Espresso stainless steel set of two stovetop coffee makers. ARV of each Entry Period 4 prize is \$445. **Total ARV for all Entry Period 4 prizes is \$4,450.**

Each Entry Period 1 prize, Entry Period 2 prize, Entry Period 3 prize, and Entry Period 4 prize will be referred to herein as a “Prize” or collectively as “Prizes”. **Total ARV for all Prizes is \$22,020.** No cash substitutions for Prizes will be permitted and Prizes are non-transferable, non-negotiable, non-refundable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute a prize of equal or greater value. **Limit one (1) Prize per person/e-mail address/household.** Federal, state and local taxes are solely the responsibility of each winner. Shipping at Prize Provider’s expense. If the Sweepstakes is terminated before the end date and time, Sponsor may (if possible), in its sole and absolute discretion, randomly select potential winners from among all eligible, non-suspect Entries received as of the date and time of the event giving rise to the termination. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Automated entries are prohibited, and any use of automated devices will cause disqualification. Either party may enforce a final arbitration award in any court of competent jurisdiction in Arlington County, VA including an award of costs, fees and expenses incurred in enforcing the award. Notwithstanding the foregoing, Sweepstakes Entities shall be entitled to seek injunctive relief (unless otherwise precluded by any other provision of these Official Rules) in the state and federal courts of Arlington County, VA. Any dispute or portion thereof, or any claim for a particular form of relief (not otherwise precluded by any other provision of these Official Rules), that may not be arbitrated pursuant to applicable state or federal law may be heard only in a court of competent jurisdiction in Arlington County, VA; (iii) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental, and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
