



FULL TERMS AND CONDITIONS FOR READY. SET. ROCKIT. BACK TO SCHOOL PROMOTION

- 1) Information on how to enter and prizes form part of these terms and conditions. By participating, entrants agree to be bound by these terms and conditions.
- 2) This promotion is open to residents of United Arab Emirates, Kingdom of Saudi Arabia (KSA), Bahrain, Kuwait, Oman and Qatar only. Entrants who are not currently residing in or are not residents of the said countries will be automatically disqualified.

This promotion is open to entrants 18 years and over. Entrants under 18 years will be automatically disqualified. Employees and their immediate families of the Promoter Company and its agencies associated with this promotion are ineligible to enter.

If Winner(s) do not meet these criteria, their entry is disqualified, and a new Winner(s) is selected at random).

- 3) An internet connection and a unique valid email address are required for each entrant.
- 4) The promotion commences at 00.01am (GMT+4) on **20 August 2022** and closes at 11.59pm (GMT+4) on **30 November 2022** (“**Promotion Period**”). Entries for Qualifying Products (see paragraph 15) purchased within the ‘promotion period’ will be accepted until 11.59pm (GMT+4) **30 November 2022**. Entries received before the ‘Promotion Period’ or after 30 November 2022 not be accepted.
- 5) There are two (2) ways to obtain an entry (an “**Entry**”) for a chance to win a Prize (as defined below) as follows:
 - a) With a Receipt: During the Contest Period, upon purchase of any one (1) of the following participating Rockit™ apple products (each, a “**Qualifying Product**” and collectively, the “**Qualifying Products**”), you will be issued a sales receipt (a “**Receipt**”). You are encouraged to remove or obscure any personal information (including payment information) that appears on the Receipt. The Photo must show: (i) the purchase of a Qualifying Product; (ii) the participating retailer name and address; and (iii) the date and time of the transaction (which must be during the Contest Period).
