

## You Choose, Tito's Gives Sweepstakes

### Official Rules:

#### **NO PURCHASE OR PAYMENT OR TEXT NECESSARY TO ENTER, WIN OR IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

The You Choose, Tito's Gives Sweepstakes ("Promotion") begins at 12:00:01 AM Eastern Time ("ET") on March 01, 2023, and ends at 11:59:59 PM ET on July 15, 2023 ("Promotion Period"). The Promotion contains a game of chance ("Sweepstakes"). The computer clock of Administrator is the official time-keeping device in the Promotion.

**1. ELIGIBILITY:** The Promotion is open only to legal residents of the 49 United States (50 U.S. other than Maine), Puerto Rico, and the District of Columbia, who are twenty-one (21) years of age or older at the time of entry. Employees, officers and directors of Fifth Generation, Inc. (the "Sponsor") and Snipp Interactive Inc. Upon confirmation of your age, you will be required to choose one (1) of the five (5) charitable organization options (each a "Charity"), and thereafter will be directed to the applicable registration form where you must completely enter your true and correct information in the required fields (required fields include Full Name, Complete Mailing Address, Email Address, Phone Number & Opt-in to the Official Rules & Privacy Policy for the Promotion). Each eligible completed registration form received will earn one (1) entry into the Sweepstakes (an "Entry") as follows: one (1) registration for the Grand Prize Drawing and one (1) registration for the Charity Drawing of the Charity initially selected.

Limit of one (1) Sweepstakes Entry per person/email address per day, throughout the Promotion Period for a total of a maximum of one hundred and thirty-seven (137) Sweepstakes Entries per person/email address.
