

**Sweet Escape - Gift With Purchase and Sweepstakes**  
**Official Rules (the "Rules")**

**SWEEPSTAKES PERIOD**

The Sweet Escape Gift With Purchase Sweepstakes (the "**Sweepstakes**") commences at 12:00:01 AM Eastern Time ("ET") on May 02, 2022 and ends at 11:59:59 PM ET on August 31, 2022 (the "**Sweepstakes Period**"). All entries must be received by 11:59:59 PM ET on August 31, 2022 (the "**Sweepstakes Closing Time**"). Entries submitted after the Sweepstakes Closing Time will not be accepted. For the Monthly drawings, a Month shall be defined as beginning 12:00:01 AM ET on the first calendar day of the month, except the first month which will exclude the first calendar day of the month and ending on the last calendar day of the month at 11:59:59 PM ET.

**ELIGIBILITY**

#### **PRIZES & ODDS OF WINNING**

There is a total of four (4) grand prizes (each, a "Grand Prize") available to be won at the outset of this Sweepstakes. Each Grand Prize consists of (1) \$1,000 Cineplex Gift Card. ARV: 1,000 each.

## **HOW PRIZES ARE AWARDED**

There will be four (4) drawings (a “**Grand Prize Draw**”) to award the Grand Prizes, subject to these Rules (including the verification and skill-testing question requirements), that will be held on 06/06/22, 07/07/22, 08/05/22 and 09/07/22, at approximately 10:00 AM ET in Mississauga, Ontario from all eligible Sweepstakes entries received during the Sweepstakes Period up to 11:59 PM ET on the day before the applicable Grand Prize Draw, except that the last Grand Prize Draw will include all eligible entries received during the Sweepstakes Period. ## **GENERAL CONDITIONS**

The Releasees are not responsible for mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, including, without limitation: failed, incomplete, garbled or delayed transmission of online entries, traffic congestion on telephone lines, the Internet or at any website or lost or unavailable network connections which may limit an online entrant's ability to participate in the Sweepstakes, and any injury or damage to entrant's or any other person's computer related to or resulting from participating in or downloading any information necessary to participate in the Sweepstakes.
