The Promotion includes a sweepstakes ("**Sweepstakes**").

Entry to the Promotion is only open to legal residents of the fifty (50) United States and the District of Columbia (the "**Eligibility Area**"), 18 years of age or older at the time of participation (each such resident, an "**Entrant**", or "**you**").

Employees of the Sponsor, Snipp Interactive Inc. (the "**Administrator**") and its and their affiliated and related companies (including, without limitation, their respective parent, sister and subsidiary companies, advertising and promotional agencies, or other party in any way involved in the development, or administration and/or marketing of this Promotion (collectively, the "**Promotion Parties**"), suppliers of materials or services related to the Promotion, or a member of the immediate family or household of any such person, are excluded from participation in the Promotion.   - "**Purchase Period**" means the period commencing on August 1, 2021 at 12:00:01 AM Eastern Time and continuing until September 17, 2021 at 11:59:59 PM Eastern Time
