

## Microsoft Xbox OPI US – Amazon US

### Terms and Conditions

**PROMOTION OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES OR DISTRICT OF COLUMBIA THROUGHOUT THE PROMOTION PERIOD WHO ARE THIRTEEN (13) YEARS OF AGE OR OLDER AT THE TIME OF REDEMPTION. VOID WHERE PROHIBITED BY LAW OR RESTRICTED BY LAW**

**IN-GAME CONTENT REQUIRES INTERNET ACCESS, HALO INFINITE GAME (AVAILABLE SEPERATELY), AND A MICROSOFT ACCOUNT.** Microsoft Corporation (“Microsoft”) and Wella Operations US LLC (“OPI”) (collectively “Sponsors”) are offering the Microsoft Xbox OPI US – Amazon US Promotion (the “Promotion”). The Promotion is subject to these terms and conditions (the “Terms and Conditions”), and by participating, a participant (“Participant”) agrees to be bound by these Terms and Conditions and the decisions of Sponsors, which are final and binding in all respects. This Promotion begins at 12:01 AM, 02/01/2022, US Eastern Time and ends on 05/31/2022 at 11:59 PM, US Eastern Time (the “Promotion Period”). Microsoft’s computer is the official timekeeping device for participation in the Promotion.

**1. Eligibility:** The Promotion is open to persons who are legal residents of, and physically located within, the fifty (50) United States and the District of Columbia and are thirteen (13+) years of age or older at the time of redemption. VOID WHERE PROHIBITED.

**2. How to Obtain a Reward Code:** To obtain a code redeemable for an OPI Exclusive Halo Infinite Armor Coating, Participants must purchase \$20 (twenty dollars) or more (after discounts/coupons and before tax) worth of Participating OPI product(s) from the list set out in [Exhibit A](#) online on Amazon.com within one (1) transaction (one (1) single sales receipt) during the Promotional Period (“Qualifying Purchase”) and take a picture of their Amazon purchase receipt. The only method for Participants to obtain a code to redeem their OPI Exclusive Halo Infinite Armor Coating (a “Reward Code”) is by visiting [amazon.opixboxrewards.com](https://amazon.opixboxrewards.com) (the “Website”) to upload an image of your Amazon purchase receipt containing a Qualifying Purchase. ***Participants will have until 06/15/2022 to claim their Reward Code;*** after such date, receipt uploads of a Qualifying Purchase cannot be redeemed, and the Website will be taken down. Participants are limited to one (1) Reward Code redemption per person/account. While supplies last.

parties consent to exclusive jurisdiction and venue in the federal courts in King County, Washington. If not, the parties consent to the exclusive jurisdiction and venue in the Superior Court of King County, Washington.
