

TOURISM REBATE INCENTIVE PROGRAM (TRIP)
(the "Offer")

Official Terms and Conditions

PURCHASE IS NECESSARY. INTERNET ACCESS AND A VALID E-MAIL ACCOUNT ARE REQUIRED. A mobile device may also be used to participate. Standard data rates may apply to participate in the Offer via a mobile device. Please contact your service provider for pricing and service plan information and rates before mobile device participation.

AGREEMENT TO BE LEGALLY BOUND BY TERMS AND CONDITIONS

By participating in the Offer, you are signifying your agreement that you have read and agree to be legally bound by these terms and conditions (the "**Terms**").

ELIGIBILITY

To participate in the Offer, you must be a legal resident of the province of Manitoba, be located in the province of Manitoba, have reached the age of 18 (eighteen) or more at the time of participation, have a valid mailing address within the province of Manitoba and a valid e-mail account. Groups, clubs, organizations, businesses and commercial and non-commercial entities cannot participate.

If it is discovered by the Sponsor (defined below) or the Administrator (defined below), using any evidence or other information made available to or otherwise discovered by the Sponsor, that any person has attempted to use multiple names, multiple identities, and/or any automated, macro, script, robotic or other system(s) or program(s), and/or any other means not in keeping with the Sponsor's interpretation of the letter and spirit of these Terms, to enter or otherwise participate in or to disrupt this Offer, then he/she may be disqualified from the Offer in the sole and absolute discretion of the Sponsor. The Sponsor, the Administrator (collectively, the "**Offer Parties**"), and each of their respective officers, directors, agents, representatives, successors and assigns (collectively, the "**Released Parties**") are not responsible for, and accept no liability whatsoever in relation to, any late, lost, misdirected, delayed or incomplete submissions (all of which are void).

THE OFFER

The Sponsor is offering eligible participants, as defined above in Section 2, the opportunity to receive a maximum of one (1) of two (2) of the following rebates:

(1) **Hotel Rebate:**

A rebate of the lesser of (a) Hundred (\$100 CDN) Canadian dollars; or (b) the total amount (after all taxes and discounts) of the Hotel Receipt (defined below) (the "**Hotel Rebate**"), when they in a single transaction (one single Hotel Receipt), purchase and pay in full for, a minimum of a one (1) night stay for a minimum of one (1) person at a Qualifying Hotel (defined below) for a stay at any time during the Offer Period (the "**Qualifying Hotel Purchase**"), and submit the applicable Hotel Receipt before the Offer Closing Date (defined below) , while supplies of Hotel Rebates last. For the abundance of caution it is hereby clarified that **the maximum amount payable as a Hotel Rebate is Hundred (\$100 CDN) Canadian dollars**, and payment for a stay in a Qualifying Hotel using any loyalty points will not be eligible to participate in this offer;

OR

(2) **Attraction Rebate:**

A rebate equivalent to fifty (50%) percent of the total amount (after all taxes and discounts) of the Attraction Receipt (defined below) (the "**Attraction Rebate**"), when they, in a single transaction (one single sales receipt), purchase and pay in full for a ticket for a minimum of one (1) person and a maximum of four (4) adults and five (5) children to visit a Qualifying Attraction, for a visit at any time during the Offer Period, and submit the applicable Attraction Receipt before the Offer Closing Date, while supplies of Attraction Rebates last. For the abundance of caution

it is hereby clarified that the Attraction Rebate will only be provided for visits to a Qualifying Attraction and not for the purchase of any memberships to a Qualifying Attraction;

The following limits apply: One (1) Rebate per eligible customer/email address.

A **“Qualifying Hotel”** is any of the registered hotels or motels in the province of Manitoba set out <http://snipp.us/!cqDgG>.

For the abundance of caution it is hereby clarified that the following accommodations are not Qualifying Hotels and any stays in, or packages purchased from, any such accommodations are **ineligible** for participation in this Offer:

- Staying at a friend or relative’s house
- B&Bs, fishing and hunting lodges
- Rental in private homes (VRBO) (AIRBnB)
- Businesses that are not in good standing or are not registered with the Manitoba Companies Office or do not have a valid and active Business Number.
- Hostels, dormitories, apartment buildings, condominium buildings, hospitals, campgrounds, short-term rental units located in privately-owned homes, apartments and condominiums.
- Accommodations supplied by employers to their employees in premises operated by or on behalf of the employers
- Time-share or life-lease establishments.
- Campgrounds or trailer parks.
- Provincial and Federal Parks passes
- Casinos

A **“Qualifying Attraction”** is any of the Manitoba Star Attractions set out <http://snipp.us/!cqDgG>.

A **“Hotel Receipt”** is a receipt issued by the applicable Qualifying Hotel confirming full payment by the applicable eligible customer for the applicable stay during the Offer Period and must contain certain information as set out below.

An **“Attraction Receipt”** is a receipt issued by the Qualifying Attraction confirming full payment by the applicable eligible customer for the ticket to visit the Qualifying Attraction during the Offer Period and must contain certain information as set out below.

A Hotel Receipt and an Attraction Receipt (together, the **“Qualifying Receipts”**, and each sometimes, a **“Qualifying Receipt”**) must contain the following information:

- Qualifying Hotel or Qualifying Attraction name and location
- Eligible customer’s name
- Date of stay or date of purchase that falls within the Offer Period
- Description of purchase
- Applicable Federal and Provincial taxes clearly identified on the receipt or
- Applicable GST registration number.
- Amount paid must be clearly identified on the receipt and **must show that it has been paid in full, i.e.,** must show a zero balance.

OFFER PERIOD; PURCHASE PERIOD AND KEY DATES

To be eligible, Qualifying Purchases, as described in Section 3, must be made **and used** between May 6, 2022 at 12:00:00 am Central Daylight Time (CDT) and May 16, 2022 at 11:59:59 pm CDT (the "**Offer Period**").

Requests (as defined below) must be submitted **after the date of the stay at the Qualifying Hotel or after the date of the visit to the Qualifying Attraction** and received by May 23, 2022 at 11:59:59 pm CDT (the "**Offer Closing Date**").

The Offer Period and the Offer Closing Date may be modified or terminated at any time at the sole discretion of the Sponsor and without notice.

The Rebates will be delivered via **mail in** the form of either a Physical Check or a PayPal® transfer, as selected by the applicable eligible customer during registration must be used in accordance with these Terms and in accordance with the Rebate Provider Terms (defined below) and Rebate Instructions.

HOW TO PARTICIPATE

To take advantage of the Offer, an eligible **participant** must follow the steps listed below:

Participants are encouraged to blank out any personal information that appears on the Receipt Image); and

(C) After the date of the stay at the Qualifying Hotel, or after the date of the visit to the Qualifying Attraction but on or before the Offer Closing Date, following the submission method listed below, submit his/her Receipt Image (each such submission, a "**Request**");

Visit Offer Site to Submit. Visit the Offer site (<https://tripmb.ca>). Eligible customers will receive further instructions on uploading the Receipt Image and registering for the Offer. Eligible customers should then complete the registration form by entering true and accurate information in the required fields (including, First Name, Last Name, Street Address, City, State/Province, Zip/Postal Code, E-Mail, Phone Number) and selecting the form in which they want their Rebate to be sent as (i.e., as a Physical Check, or as a PayPal transfer. Follow instructions and submit Receipt Image and Request (including reading and accepting any required terms and conditions) and register for the Offer.

SNIPP will send a confirmation of eligibility or ineligibility to the email address provided during registration 72 hours from successfully qualifying for the Rebate. Processing of a Request will take 72 hours from the time the Request is received by or on behalf of the Sponsor. Once your

Request is processed, you will be notified via email, whether such Request has been successfully validated or a reason why such Request could not be processed at such time, as determined by the Administrator in its sole and absolute discretion. It is your responsibility to check the applicable email account for such notification including in the **inbox, spam or junk folders**. The Released Parties do not assume any responsibility and are not responsible for electronic communications which are undeliverable for any reason, including (but not limited to) as a result of any form of active or passive filtering of any kind or insufficient space in your mailbox or telephone to receive e-mail messages, text messages or other communications. All Requests and Receipt Images shall become the property of the Sponsor and will not be returned. Offer is void where taxed, prohibited, or restricted by law.
